1. Sealed competitive quotations are invited by the undersigned for supply of Inj. Anti Rabies Vaccine (ARV) to Medical College Hospital VIMS, Ballari.

II. Terms and Conditions:-

1. The Firms should quote for the items in the format of quotation attached.
2. Name and correspondence address should be rubber stamped over the sealed competitive quotation.
3. All Duties, Taxes and other levies payable by the Firms (including sales tax on the finished goods) shall be included in the item rate.
4. The Rates quoted for item shall be fixed for the duration of the contract and shall not be subject to any adjustment.
5. Rates for supply of partial quantity of an item will not acceptable.
6. Corrections if any shall be made by crossing out, initialing, dating and rewriting.
7. Supply should be door delivery with freight paid basis.
8. Supply should be made within 07 days from the date of receipt of Supply Order.
9. Supply of items should be any of ISI or ISO or CE or any relevant quality certified.
10. No advance payment will be made.

III. Each Firm must submit only one quotation.

IV. Validity of quotations

The quotation shall remain valid for a period not less than 90 days after the deadline fixed for submission of quotations.

V. Evaluation of quotations

1. The purchaser will evaluate and compare the quotations determined to be substantially responsive i.e., which are properly signed, and conform to the terms and conditions and specifications in the following manner.
2. The evolution will be done including the Sales Tax. If the Firms has not included the Sales Tax in his Quotation for the item rate, and also not indicated the rate of sales tax applicable, the quoted rate will treated as though it is inclusive of the sales tax and no extra payment for sales tax will be made.
3. The Firm who has quoted for partial quantity of an item would be treated as non-responsive. Purchaser will award the contract for each item separately to the lowest responsive Firms for that item.

VI. Award of contract


1. The purchaser will award the contract to the Firm whose quotation has been determined to be substantially responsive and who has offered the lowest price as per Para 5 (2) above.
2. The purchaser reserves the right at the time of contract award to increase or decrease the quantities of the Item indicated in Para 1 above by 25% without any change in the price or any other terms and conditions.
3. The purchaser prior to the expiration of the quotation validity period will notify the Firms whose quotation is accepted of the award of contract. The terms of the accepted offer shall be incorporated in the purchaser order.
4. Normal commercial warranty/guarantee shall be two years from the date of installation of the goods.
5. The payment will be made on receipt of full supply and satisfaction report from the concerned.
6. Not withstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the quotation process and reject all quotation at any time prior to the ward of the contract.

7. In case at any point of time if it is found that the quoted prices are not at par to the prevalent market price, the Institute liable to take necessary action for refund of excessive amount.
8. The terms of the accepted offer shall be incorporated in the purchase order.


